Report of the Superintendent of Schools
Dr. Elizabeth Lison

Superintendent Lison reported that the Board will vote on a resolution to adopt the proposed 2009-2010 budget of \$40,991,386, which is an increase of \$563,579 from the current budget, or 1.39%. This budget preserves the high quality education that our residents have come to expect, while maintaining our obligation to be fiscally responsible. Willow Road PTA will host a presentation by the Nassau County District Attorney's Office called *Not My Child*, on Tuesday, March 31 at 7:00 PM. This program deals with drug abuse, and all fifth and sixth graders were invited with their parents. Once again, fifth graders participated in Assemblyman Alfano's Mentors and Leaders Program in Albany. Photos are available on Assemblyman Alfano's Facebook homepage. Dever celebrated *Wild About Reading* PARP with author Jim Brochac who visited with K-6 classes; Willow was named on the March of Dimes website for raising more than \$10,000 over the past three years; Wheeler Grade 6 students video-conferenced with astronauts at NASA, Cape Canaveral to learn about the earth's atmosphere, astronaut daily life in a space shuttle and new data learned about Mars's atmosphere and surface since Mars is going through a global warming; and Howell is planning to hold Career Day on April 3rd and 25 parents and community volunteers are scheduled to speak with students regarding their careers.

Resolved, that the Board of Education of Valley Stream Union Free School District Thirteen approves the establishment of a retirement contribution reserve for the purpose of financing retirement contributions to the New York State and Local Employees Retirement System, in accordance with the provisions of General Municipal Law Section 6-r. There may be paid into a retirement contribution reserve fund: such amounts as may be provided therefore by budgetary appropriation or raised by tax thereof; such revenues as are not required by law to be paid into another fund or account; such other funds as may be legally appropriated or transferred. The Board of Education may, by resolution, authorize expenditures from a retirement contribution reserve fund as permitted by law. The Board of Education, by resolution, may determine that a retirement contribution reserve is no longer needed and terminate the fund. Such resolution shall transfer any moneys remaining in such fund to one or more reserve funds of the district, established pursuant to section thirty-six-hundred fifty-one of the Education law or Article 2 of the General Municipal Law.

**Report of the Attorney
Florence Frazer**

Attorney, Florence Frazer, explained the Temporary COBRA Premium Subsidy. When an employee is laid off between the period of September 1, 2008 through December 31, 2009, they may become eligible for COBRA payments subsidized by the federal government for nine months at a rate of 65%. He/She can continue health insurance coverage for up to a period of 36 months, however, by incurring the expense. Districts must notify individuals who were terminated during the relevant period that they may be eligible for the COBRA subsidy and must send out new premium statements. A copy of the memorandum dated 3/12/09 from Frazer and Feldman is attached to the official minutes.

Old Business

Trustee Chiachiere explained the topics of discussion at the PTA Legislative Breakfast held on Saturday, March 14. Superintendent Lison spoke on behalf of the four Valley Stream Districts regarding the disproportionate amount of taxes that downstate districts pay, and the importance of bringing in a timely state budget. Afterwards, elected officials were present to meet with residents.
