Section 1. The Board of Education of the Valley Stream Union Free School District Thirteen (the "School District") has received proposals from Capital One Public Funding, Banc of America Public Capital Corp., Municipal Leasing Consultants, and Sun Trust Equip. Finance & Leasing Corp four (4) firms to provide financing for the Energy Performance Contract that the School District has heretofore entered into with Con Edison Solutions (the "Agreement").

Section 2. Following a discussion of the Board of Education of the School District, and based upon the written recommendation received from New York Municipal Advisors Corporation, the School District's Financial Advisor, it is hereby determined that the proposal of Capital One Public Funding (the "Lessor"), which represents the lowest responsible bid received by the School District, is hereby accepted.

Section 3. The President of the Board of Education, the Vice President of the Board of Education, the Superintendent of Schools and/or the Assistant Superintendent for Business (collectively the "Authorized Representatives" and individually, the "Authorized Representative") acting on behalf of the School District, are hereby authorized to negotiate, enter into, execute, and deliver one or more lease purchase agreements (the "Equipment Lease") with the Lessor. The Authorized Representatives are hereby further authorized to negotiate, enter into, execute, and deliver such other documents relating to the Equipment Lease (including, but not limited to, escrow agreements) as the Authorized Representatives deem necessary and appropriate. All other related contracts and agreements necessary and incidental to the Equipment Lease are hereby authorized, and such documents shall be filed in the office of the District Clerk and made available for public inspection.

Section 4. The aggregate original principal amount of the Equipment Lease shall not exceed the \$5,417,700 and shall bear interest as set forth in the Equipment Lease and shall contain such options to purchase by the School District as set forth therein.

Section 5. The School District's obligations under the Equipment Lease shall be subject to annual appropriation or renewal by the Board of Education of the School District as set forth in each Equipment Lease and the School District's obligations under the Equipment Lease shall not constitute a general obligation of the School District or indebtedness under the Constitution or laws of the State of New York.

Section 6. The proceeds of the Equipment Lease may be applied to reimburse the School District for expenditures made after the effective date of this resolution for the purpose for which said proceeds are authorized, or on or prior to such date if the Board of Education of the School District has adopted a prior statement of intent to issue bonds for such purpose. The foregoing statement of intent with respect to reimbursement is made in conformity with Treasury Regulation Section 1.150-2 of the United States Treasury Department.

Section 7. The Authorized Representatives are hereby authorized to take any and all other actions necessary in connection with the Agreement, the Equipment Lease, and all matters related thereto.

On May 14 the Valley Stream Central High School Board awarded tenure to administrators and teachers. The maintenance Supervisor, James DeVito retired after 38 years with the district. Various operating contracts were approved.

Report of the Attorney

Florence Frazer

Parents instructed their child to refuse to take the standardized tests, claiming that that test is unfair, unnecessary, unduly stressful, and harmful. The parents notified the District in advance, and they were informed that refusal would amount to insubordination from which disciplinary action could result. The student refused to take the test, and the District imposed discipline: the District prevented the student from participating in extra-curricular activities on testing days when he refused to take the tests. Parents claimed that disciplinary action denies their right to free speech and a free public education. The State Court denied the parents request for a temporary restraining order because the parents had cited no authority to support their claim that a District's insubordination decision, and its subsequent notation in the student's academic record, constituted irreparable harm.

New Business

Trustee Stris attended a seminar on School Safety.

Trustee Stris made a motion for the approval of a conference entitled New School Board Members, with all expenses paid by the district, Trustee DiSibio seconded the motion, and it was carried unanimously.
