Report of the Attorney
Florence Frazer

Attorney Frazer reported on a recent Supreme Court decision in Westchester County whereby the decision of a Section 3020-a hearing officer who terminated a tenured guidance counselor based on her constant and open criticism and disparagement of her fellow counselors, was upheld. The teacher’s attitude constitutes “conduct unbecoming a teacher.”

New Business

Trustees Stris, Chiachiere, Greco Jacobs and Superintendent Lison attended the New York State School Boards Convention workshops and Law Conference on October 21-24, 2010. Trustee Stris Gave a short review of the workshops he attended. He reported that he has written to the Committee on Open Government in Albany to get an opinion on: (1) whether or not the public can FOIL the new teachers and principals ratings; (2) the new rules on board meetings being teleconferenced. The district should hear in writing in the near future on these two items.

Visitors

Krista Testani had several questions concerning the recent proposal to consolidate the Valley Stream School Districts. President Chiachiere advised that there was a study on consolidation several years ago. Before the Boards of Education can hold another study, the four school boards must vote on a resolution to hold said study. The meetings will be open to the public and ultimately, the district residents would have to vote on consolidating the four districts into one school district. To date, Valley Stream Central High School, Valley Stream #30 and Valley Stream #13 have voted to participate in a consolidation study. In the near future, Valley Stream #24 will vote on whether to participate.
