Trustee Greco Jacobs asked if the use of anti-bacterial soap, to be used in the classrooms, is included on our supply list. Mrs. Brosnan advised that it will be included next year.

There were some questions regarding the memo from attorneys Lamb & Barnosky concerning cancer screening and nursing mothers at the work place; the district will allow ½ day for cancer screening; and mothers are permitted to pump breast milk at designated rooms in the district.
