Proof of Residency:

- District 13 class lists will be used to verify the residency of District 13 children.
- Bus lists will be used to check residency of private school children who receive bus transportation.
- All other children must provide proof of residency with a copy of mortgage statement, or tax receipt, a lease, and two additional proofs, utility bill, cablevision, etc., proof of school presently enrolled in. (i.e., a copy of a recent report card showing the school's name). Additional proofs may be required upon request.

YOUR REGISTRATION FORM WILL BE RETURNED IF REQUIRED PROOFS ARE NOT INCLUDED. DO NOT SEND ORIGINALS. SEND COPIES ONLY. PROOFS OF RESIDENCY WILL NOT BE RETURNED.

Since a large number of children register for this program, registration will not be confirmed by telephone or mail. Please send your child on the first day to the school your child will be attending the program. Any registration problems will be resolved at that time.

Grouping: Children are grouped according to their grade in school.

Children that do not behave according to the Valley Stream UFSD Code of Conduct will be dismissed from the Summer Recreation Program.
