It's that time again! Time to register your child for the Valley Stream Recreation Department's Barrett Park Program. The program begins Wednesday, June 27th, and ends Friday, August 10th; daily from 9:00 A.M. - 12:00 noon, weather permitting. Children must be entering kindergarten in 2018 up to 6th grade (**PLEASE BRING BIRTH CERTIFICATE**). As this is a popular program and space is limited. Registration is held on first come, first serve basis.

The program cost is \$250.00 for the first child and \$110.00 each additional child for village residents; \$300.00 for CHD residents with \$195.00 for each additional child.

Payment may be made by check or money order made out to the Inc. Village of Valley Stream, exact cash or credit/debit card. The Barrett Park Program is restricted to Inc.

Village and CHD residents **ONLY**.
