1. Appointment of Permanent Substitute Teachers

2. Appointment of Part-Time Psychologist

To appoint Leslie Gulkis as a Part-Time (.4) Psychologist on Step 2MA+30 (\$77,894), prorated for the number of hours worked, effective September 18, 2019 through June 30, 2020 and unless sooner terminated.

3. Amendment of Resolution

RESOLVED, the Board hereby amends the resolution adopted on August 20, 2019, to employ Soneya Bonetti as a Part-Time (.5) ENL Teacher to substitute the language “on Step 2MA (\$72,928)” with “on Step 2MA+15 (\$75,619) effective September 1, 2019.

4. Amend Part-Time Social Worker Position

6. Appointment of Noon-Hour Aides

To appoint Esther Okafor as a Noon-Hour Aide assigned to the Wheeler Avenue School at a rate of \$12.25 per hour effective September 18, 2019 pending civil service approval and unless sooner terminated.

To appoint Laleta Muneshwar as a Noon-Hour Aide assigned to the Howell Road School at a rate of \$12.25 per hour effective September 18, 2019 pending civil service approval and unless sooner terminated.

7. Appointment of Classroom Aide

To appoint Aisha Mohammed as a Classroom Aide assigned to the Wheeler Avenue School on Step 1 (\$17,320) effective September 18, 2019, pending civil service approval and unless sooner terminated.

8. Amend Part-Time Physical Education Teacher Position

RESOLVED, the Board of Education hereby increases the position of James Cundari as a Part-Time Physical Education Teacher from .7 to .85, on Step 2MA (\$72,928), prorated for the number of hours worked, commencing on September 18, 2019 through June 30, 2020 and unless sooner terminated.

To appoint Krystal Rosado, Classroom Teacher at Wheeler Avenue School (Tenure Area: Elementary Education) on Step 1M (\$70,576) on four years' probation commencing on September 18, 2019 and expiring on September 17, 2023 and unless sooner terminated. (*See note below)

**In order to be eligible for tenure, an individual receiving a probationary appointment as a classroom/special education teacher must receive annual composite or overall APPR ratings of H or E in at least three of the four preceding years, and if the individual receives a rate of I in the final year of the probationary period, he or she will not be eligible for tenure at that time.*
