## V. S. Recreation Program At Barrett Park Registration 2017

### Dear Parents:

It's that time again! Time to register your child for the Valley Stream Recreation Department's Barrett Park Program. The program begins Thursday, June 29<sup>th</sup>, and ends Friday, August 11<sup>th</sup>; daily from 9:00 A.M. - 12:00 noon, weather permitting. Children must be entering kindergarten in 2017 up to 6<sup>th</sup> grade (**PLEASE BRING BIRTH CERTIFICATE**). As this is a popular program and space is limited. Registration is held on first come, first serve basis. The program cost is \$240.00 for the first child and \$105.00 each additional child for village residents; \$290.00 for CHD residents with \$185.00 for each additional child.

Payment may be made by check or money order made out to the Inc. Village of Valley Stream, exact cash or credit/debit card. The Barrett Park Program is restricted to Inc. Village and CHD residents **ONLY**.
