TRANSPORTATION REQUEST for 2021-2022 SCHOOL YEAR

Dear Parent/Guardian:

Valley Stream UFSD Thirteen provides private or parochial school transportation for students in grades K - 6 * who meet our district's transportation policy guidelines.

Please complete the attached application to request transportation for your child(ren) for the 2021-2022 school year. Proof of residency must be provided **each** year. In addition, proof of birth date (birth certificate, passport, etc.) is required for ALL first time applicants.

To qualify for transportation, in addition to meeting the district's policy guidelines, an application **must** be on file for the specific school your child(ren) will ultimately be attending. Therefore, **it is strongly suggested that you file applications for more than one school if you have not yet decided on one.** You may submit up to three applications per family.

Please make sure to include an email address on your application to receive confirmation of receipt and to be added to our email distribution list.

Applications must be hand-delivered to our Business office or postmarked **no later than Thursday, April 1, 2021.** No applications will be accepted after that date. Our office is open from 8:00 A.M. to 4:00 P.M., Monday through Friday. Mailing with tracking/delivery confirmation is strongly recommended. We accept no responsibility for lost/misdirected mail, or for any undelivered electronic communications. WE DO NOT ACCEPT FAXED OR EMAILED APPLICATIONS. Please call our office at 516-568-6110 to confirm receipt of your application if you do not hear from us before the deadline.

* IMPORTANT: For students entering grade 7 or higher, a separate application must be submitted through the Valley Stream Central High School District. Please visit their website at <http://www.vschs.d.org> for application/more information.
